Dear Vendors:

As we prepare for Lincoln University's 2022 Homecoming celebration, the Student Life and Development Office invites you to participate in the dates of the upcoming events:

Merchandise & food vendors interested in vending during Homecoming Weekend (Thursday 10/06 – Saturday 10/8) may do by submitting a vendor application by **September 16th**, **2022**. **Upon approval**, you will be directed to pay the appropriate fee (\$750 food, \$400 merchandise). **Due to changes in our vendor set-up process**, we have a limited number of spaces available this year for vendors. We are inviting you to participate each day, however, if you cannot, please let us know which days you plan on attending, by completing that section on the application.

As a reminder, vendors must secure a certificate of liability insurance. Vendors will participate during the following times:

Thursday, October 6th: set-up 9AM – vending starts at noon Friday, October 7th: set-up 9AM – vending starts at noon

Saturday, October 8th: Vending starts at 10:00 am and concludes at 10:00 pm.

** Unfortunately, tables are not provided, but each vendor is allowed to bring up to two (2) tables. **

Vendors are not allowed to park in the vending area, cars are only permitted to load/unload in the space. Public safety will ticket and/or tow your vehicle if you fail to follow parking regulations on campus. A parking pass will be sent to you upon approval of your application and payment. Vendors are responsible for appropriate cleanup and disposal of all materials.

Vendors selling merchandise with any Lincoln logo, seal, or mark must be licensed via CLC Brand Manager. All merchandise with logo, seal, or mark will need to be pre-approval through CLC. Licensing information can be found at <u>University Branding | Lincoln University</u> and then scroll down to Licensing.
