Lincoln University Faculty Regular Meeting Minutes Tuesday, 3 October 2017, 4 PM Ware Center Theater

The meeting was called to order by Provost and Vice President Ramsey at 4:05 p.m.

A. PRESIDENT'S REMARKS, Dr. Brenda Allen

- a. In the President's report to the BOT, she recommended a liberal arts direction. She stated that a rigorous classical education helps students to succeed and have an impact on society. College graduates need to be able to retool in a global society. Graduates will have to change jobs 20-30 times ... returning to a rigorous liberal arts education will allow graduates to have the intellectual flexibility to retool as the market shifts.
 - i. A question was asked regarding the assessment data used that led to the recommendation. The President responded that she reviewed the LU catalogs that indicated that the liberal arts has been removed and not currently a part of the mission statement. The University has moved away from liberal arts at part of the core mission. The strategic plan will help align that mission to the liberal arts.
 - ii. A question of diversity led to a response to define the concept as the collection of outlooks and opinions and perspectives.
 - iii. The President made a point that our mission needs to be "re-clarified" as opposed to changed.
