# Lincoln University Faculty Regular Meeting Minutes Tuesday, 6 September 2016, 4:00PM Ware Center Theater

# Patricia Pierce Ramsey, Ph.D. Provost and Vice President for Academic Affairs Presiding

The meeting was called to order by the Provost and Vice President Ramsey at 4:02 p.m.

### I. PRESIDENT'S REMARKS, Dr. Richard Green

- Rendall Hall renovations were completed and the dormitory is open.
- Return of a stolen item—Dr. Green showed off a knife in a leather sheath that had been stolen from the University in 1969 by a transfer student as an act of revenge and recently returned to Lincoln.
- New additions: Dr. Green welcomed the new Provost, Dr. Ramsey, the interim Vice President of Student Affairs, Dr. Berry, interim Athletic Director, Anthony Pla, and Band Director Timothy Chambers. Blake Bradford is a visiting Assistant Professor from the Barnes Foundation. A search is underway for a Vice President of Institutional Advancement.
- Number of students: The enrollment has been increased from last year. There is the potential for 2201 enrolled students. Last year at this time the university had 1902 enrolled students.

### II. PROVOST REMARKS, Dr. Ramsey

- Model the best for our students—Dr. Ramsey reiterated her message from the faculty conference that the faculty needs to "model the best" in order to show students how to strive for excellence.
- She complimented the band's self-examination to work hard, learn to read music, and perform at their very best.

- Enrollment management has been moved to Academic Affairs. Kimberly Taylor-Benns reviewed the enrollment management process of attracting, admitting, retaining, and graduating students. She presented a general overview of enrollment management aspects such as new software to stay in touch with

applicants, a tuition freeze, scholarship packages based on ACT/SAT scores and high school GPA, recruiting partnerships, the First Year Experience program, and a continual nurturing support for students throughout their career. She asked that students be allowed to volunteer for open house on Friday, 4 November 2016. Commitment Day is Friday, 31 March 2017, for high school seniors. Programs are encouraged to hold information sessions.
