Rationale of clusters and responsibilities of liaisons:

Introduction: Faculty council has classified faculty-standing committees in four clusters, Campus life, Faculty resource, Department specific and Faculty enrichment. Main goals of this exercise are as follows:

- (1) Find common elements of the committees in each clusters.
- (2) Facilitate communication and collaboration among committees.

Cluster one (Campus Life):

(1) Admissions, Academic Standing and Financial Aid (2) Campus Activities, (3) Honors, Awards and Honorary Degrees (4) Juridical Review (5) Athletics (6) Student Health and Welfare

Cluster two (Faculty resource):

(1) Assessment and Evaluation (2) Distance Learning (3) Educational Policies (4) General Education

(5) Faculty By-Laws (6) Judicial Review

Cluster three (Department specific)

(1) Library and Information Technology (2) Curriculum Committee (3) Writing (4) Graduate Studies (5) Study Abroad.

Cluster four (Faculty enrichment)

(1) Nominations (2) Faculty Research and Development Committee (3) Pre-Tenure Review

(4) Post-Tenure Review (5) Promotion, Tenure and Severance

Faculty council executive members will appoint a team of two or three liaisons to work with each cluster.

Tasks:

- 1. Attend meetings when it is possible.
- 2. Bring progress report to the faculty floor.
- 3. Bring proposals to the faculty council.
- 4. Prepare annual cluster report.

To recognize and document commonality among committees: FC liaisons assign to a cluster must read 'committees responsibility document' thoroughly and prepare a task flow chart. To achieve this they may do the following:

- a. Call for a common meeting of the committee chairs and get their insight to their task.
- b. Send out a survey to the faculties who may have served in the past.
- 2. Facilitate conversations among committee members: FC liaisons must attend, and if required call a committees meetings and make recommendations on to improve their functions.
- 3. Facilitate annual workshop for each cluster.
- 4. Collect committee reports and assess their performance.
