Dear Vendors:

As we prepare for Lincoln University's 2025 Homecoming Celebration, the Student Life and Development Office invites you to participate in the dates of the upcoming events:

Merchandise & food vendors interested in vending during Homecoming Weekend (Thursday 10/23 – Saturday 10/25) may do by submitting a vendor application by October 8th, 2025. Upon approval, you will be directed to pay the appropriate fee (\$850 food, \$500 merchandise by 10/08). Due to changes in our vendor set-up process, we have a limited number of spaces available this year for vendors. We are inviting you to participate each day, however, if you cannot, please let us know which days you plan on attending, by completing that section on the application. Note, there is not a separate fee per day.

As a reminder, food vendors must secure a certificate of liability insurance by 10/08. Vendors will participate during the following times:

Thursday, October 23rd: set-up 9AM – vending starts at noon Friday, October 24th: set-up 9AM – vending starts at noon

Saturday, October 25th: Vending starts at 10:00 am and concludes at 10:00 pm.

** Unfortunately, tables are not provided, but each vendor is allowed to bring up to two (2) tables. **

Vendors are not allowed to park in the vending area, cars are only permitted to load/unload in the space. Public safety will ticket and/or tow your vehicle if you fail to follow parking regulations on campus. Vendors are responsible for appropriate cleanup and disposal of all materials.

Vendors selling merchandise with any Lincoln logo, seal, or mark must be licensed via CLC Brand Manager. All merchandise with logo, seal, or mark will need to be pre-approval through CLC. Licensing information can be found at <u>University Branding | Lincoln University</u> and then scroll down to Licensing.

Please note that vendors who fail to submit payment or obtain their licensing by the deadline will not be permitted to vend and will lose their spot.
